Brothers and Sisters,

As previously explained in Secretary Kempke's email, the \$2,000 grants were awarded to Danbury, Startford, Willimantic and New Milford. I would ask that your itemized list; including place of purchase, items to be purchased, cost and item numbers be emailed to Cortina. I received hard copies, some of which were incomplete or being altered, therefore this is the quickest and easiest way to get your items to you. This would also be the time to alter your list if you decided on a different company, model or K9 item you wanted on your list. Please make sure your items reach the \$2,000 mark. You get a full \$2,000 so don't sell yourself short with equipment. If your bill goes over \$2,000, just send a check for the remaining amount over \$2,000 to Cortina. Once Cortina receives your itemized list, Cortina will order the items, pay for them and have them sent to your agency.
