FORMS DUE TO COUNCIL BY March 4, 2022

- HCenter noted that a new painting has been commissioned for the Marian Anderson Studio by the Music Centre and will be displayed in the studio, upstairs.
- J. GSmith had asked the Coordinator to research grants for Murals.

- GSmith noted that he wanted information specific to the mural in the Commission office, not in general.

Old Business

1. ACE Scholarship

Moved by GSmith to increase the Scholarship budget to a total of \$5,000, One thousand (\$1,000) for each of 5 scholarships to be distributed as follows: 1 for Art at Alternative Center for Excellence, 1 for Art at Henry Abbott Technical High School, 3 at Danbury High School for Art (BDaSilva), Music (MSiegel), and Theater/Dance. Seconded by JCooke.

DISCUSSION: HCenter - this is a good way to honor the memory of Joe Pepin, the school's founder, and increase the awareness of the Cultural Commission.

CALLED: Passed by unanimous voice vote.

JCooke asked if the Commission tracks the eventual employment fields of past scholarship winners. The Coordinator has no information in the files. A request to have students stay in touch will be undertaken.
