Dear Mr. Ashkar:

I write on behalf of Conanicut Aviation, LLC, which, as you know, maintains a facility at Danbury Airport. Specifically, that facility is located at 49 Miry Brook Road.

Executive Air Service, LLC, operates an FBO at 53 Miry Brook Road, the address apparently approved by the airport Administrator, the Planning & Zoning Department, and the City's emergency responders. Unfortunately, through some mix up years ago, Executive Air began to use 49 Miry Brook Road. It continues to use that address to this very day.

As you can imagine, the use of the same address by two Airport facilities can cause confusion on the part of both emergency responders and customers. With heightened levels of security and danger in aviation, this situation should not continue. Conanicut and various City officials have called this problem to the attention of Executive Air, but the company persists in using the improper address.

Accordingly, we ask your agency to order Executive Air to use its proper address immediately. Would you please schedule this matter for your next meeting?
